<b>Opportunity Fund Camp Grants</b>	Mount Baker Council provides limited assistance on an individual basis to those Scouts who could not otherwise attend summer camp due to financial hardship. For consideration, a Camp Grant application must be completed online by April 15. Scouts who apply for a campership are still responsible for the remaining camp fee balance due and must adhere to the payment schedule.

## ***The 2019 Scouts BSA Summer Camp Reservation Process***

Our 2019 Summer Camp registration platform is moving completely online giving you more control of your registration. Under this system there are two registration periods, a “Pre-Registration” period and a regular “Registration” period.

### **MAKING A RESERVATION**

#### **1. Pre-Registration Period - until 2/15/19**

For units that register during this period, a \$250 deposit and an estimate of youth & adult attendance is required.

#### **2. Registration Period - starts 2/15/19**

For units that register during this period, units will not need to pay a registration deposit but will need to specify the number of participant (youth & adult) slots needed for summer camp and pay the **non-refundable \$25/Scout deposit**. A minimum of 2 trained registered adults over age 21 is required. In troops for girls, at least one of the trained registered leaders over age 21 must be female.

- ❖ Any unit may make a registration for any available session of Fire Mountain Scouts BSA Summer Camp for 2019. A non-refundable registration fee equal to \$25 per Scout reserved will be due at that time and the minimum registration must be at least \$250 (10 slots). The unit may select less than 10 slots, but the amount due will be a minimum of \$250. The unit is now financially responsible for the number of slots requested (minimum \$250).
- ❖ Individual names do not have to be specified at this time but can be if the unit chooses to do so.

- ❖ Units may add new slots, if space is available, as needed. Prior to confirmation (2/15), you can also reduce your slots. Once confirmed, units must contact the council office to reduce the number of slots and the \$25/Scout deposit is forfeited. until the end of the Registration Period (5/15/19). After 5/15/19, all reduced slots are subject to a 25% refund fee. Units may make changes to existing slots until midnight on the Saturday before their arrival at camp. (i.e. changes to name of Scout or adult attending).

### **ESTIMATE CONFIRMATION and \$25 per Scout deposit – due by 2/15/19**

Starting 2/15, units that made their reservation during the Pre-Registration period are required to confirm their estimated numbers (based on camp availability) and the camp fee due at that time will be equal to \$25 per confirmed participant slot. The \$250 deposit made during pre-registration needs to be allocated to individual slots at this time. **Do not confirm a slot unless you have a committed participant. This \$25 per Scout deposit is non-refundable.** If slots are not confirmed within 10 days, they may be released to allow space for those units on the waitlist for that week.

### **First Payment due by 4/1/19**

For existing reservations, an additional \$155 participant payment is now due for each youth slot reserved (\$180 total due for each slot reserved) and \$75 per adult slot. The camp fee due for **new** reservations made at this time will be equal to \$180 per youth slot and \$75 per adult. Girl and 2<sup>nd</sup> week camper fees due are \$100 total by 4/1/19.

***Opportunity Fund Camp Grant requests must be submitted by 4/15. Available for Mount Baker Council youth only.***

### **Final Payment and Registration Information due by 5/15/19**

- ❖ Units supply all participant names and Youth Protection dates for adults attending camp by this time.
- ❖ Units paid in full may begin to select Merit Badges for participants when Merit Badge sign-ups open late May/early June.
- ❖ **Full payment for remaining camp fees is now due for early bird price.**
- ❖ Units may make edits to existing slots until midnight on Saturday before their arrival at camp. If there is still space, units may add to the number of slots in their reservation provided full payment is made online and they can accommodate the additions in their campsites.

### **Camp Notes and Reminders**

-Do not confirm a slot unless you have a committed participant. The Mount Baker Council refund policy applies once you confirm a registration slot. New Scouts/Webelos Crossovers can be registered at a later date. Please review the refund policy prior to committing funds.

-All Scout payments made after May 15 will be charged \$380 for in-council/\$395 for out-of-council, except for new Scouts BSA members. Fees paid at camp increase to \$390 for in-council/\$405 for out-of-council. All outstanding camp fees must be paid in full upon arrival at camp.

-We strive to accommodate campsites requests whenever possible; however, final determination is based on many factors including paid registration numbers, campsites availability, special needs requests, etc. In some cases, two or more units may share a campsites.

-Current online payment options: credit card (3% convenience fee added), eCheck and mail-in. If mailing, include your name, unit number, phone and registration number! In-council units who wish to use their unit account may contact a Service Center by phone or in person. You must go into your registration to ALLOCATE the funds to your attendees after payment is received and entered. Note: there is a \$35 fee added for returned checks and eChecks.

All attendees - youth and adult - must be registered with the Boy Scouts of America. ALL Adults must have a completed background check and current Youth Protection training. Each unit must have at least two BSA-registered, TRAINED leaders over 21 years present at camp.

A current BSA Annual Health & Medical Record is required for every participant – youth and adult, and must be presented during camp check-in. Do not mail your medical forms to camp or a Service Center. Medical forms are valid for 1 year from the last day of the month in which it was signed by the medical professional (i.e. if the doctor signed it July 2, 2018 it is good until July 31, 2019). No participant is allowed at camp without a valid BSA Annual Health & Medical Record. Sports or school physicals are not acceptable for camp.
